CALL TO ORDER-WELCOME VISITORS

PROGRAM REVIEW: FACILTIY STUDY - STRUXTURE ARCHITECTS

Ms. Miller explained her company's research methods, the data collected, and presented the options StruXture arrived at due to their findings. The board asked for clarification on several issues, which Ms. Miller and Sam Miller answered to the board's satisfaction. Sam Miller stressed the fact that this study is for the purpose of presenting options, not recommendations to the board. The lease agreement with LSI was approved on a motion made by Dr. George North and seconded by Bryan Burton. Motion carried.

APPROVAL OF EDUCATIONAL AGREEMENT WITH FOUR OAKS FOR 2016-17

The educational agreement with Four Oaks Family and Children's Services was approved on a motion made by Dr. George North and seconded by David Giese. Motion carried.

REPORTS TO/FROM THE BOARD:

Dr. Jerry Schnabel's Report:

Jerry shared the video *What AEA 267 Does For Me*. The board thanked Beth Strike and her team for the wonderful job they did producing this video.

Dr. Mary Stevens' Report:

Mary reported that she has hired six new team representatives, four speech-language pathologists, two speech-language assistants, one audiometrist, one occupational therapist, and one early childhood educator.

Dr. Julie Davies' Report:

Julie reported that the new statewide professional development registration is set for a January 1, 2017 release date. Over 100 educators recently attended a reading workshop, which was a great success. Julie shared that she has hired five new consultants, with three holding doctorate degrees.

Dr. Jon McKenzie's Report:

Jon shared that 75 people from six districts are involved in assessment training. These trainings will continue for large-scale assessment.

Karl Kurt's Report:

Karl reported that the new staff orientation was a success and thanked the HR staff for their involvement.

Sam Miller's Report:

Sam shared the news that Dr. Monte Selby who was scheduled to speak at the All Staff Meeting was unable to obtain a flight to Iowa. Sam is working on securing an alternate speaker for the event.
