A webinar about the AEA and K-12 desk audit is posted in two places on the department website, the Differentiated Accountability page and the CASA page. Guidance documents are also posted on these pages as is a webinar for those districts volunteering to pilot the Preschool Desk Audit.

The desk audits are designed to be easy to understand and utilize for providing evidence of compliance with accreditation standards. Each section of the desk audit includes two avenues for additional information, a blue information circle, or a blue hyperlink to the CASA webpage. BEWARE OF FREE GRANT WRITING – 21st CENTURY COMMUNITY LEARNING

Some companies operate online "free" grant writing services that are not free. Some require a signed contract before receiving an award that require a purchase from a third party in exchange for their services if awarded.

21st Century Community Learning grant funds cannot be used before the award is received and any purchases must be allowable. Agreements entered into before receiving a grant award are not payable with 21st Century Community Learning funds. Consider contacting your attorney before entering into any agreements.

From Evaluation Guidelines in Request for Application (RFA): No more than 4% of each program's total budget can be used for local evaluation efforts. You may NOT use grant funds to pay for grant writing or make purchases, enter into any contract or incur expenses before you have a signed grant agreement. –pg. 22 of Iowa RFA

Grant Writing expenses are paid with your funds: Example: If you receive an award of \$100,000- You may spend up to \$4,000 on local evaluation and are not reimbursable with grant funds.

The competition is currently open for 21st Century Community Learning Centers grant. You must have a minimum of 40% free and reduced lunch for each building you serve and you must make a commitment to provide a minimum 60 hours of programming per month.
