Critical Budget Deadlines

Requirement	Deadline
Budget Publication	10 to 20 days prior to official Board Hearing of budget
Board Adoption of Budget (Official hearing is many times on this same date)	Prior to April 16th
Notice of successful elections on ISL, PERL, PPEL	No later than April 16th
Budget Guarantee Resolution	To DOM by April 16th
Due date to DOM and County	April 16th
FY 2018 Budget Amendment Resolution	No later than May 31, but before exceeding budget

IASB also updated the sample policies that reference board member election dates to reflect changes in the law.
