## SECOND CHANCE READING

### **Description: Course # 3902 Section # 30638**

Second Chance for Struggling Readers is a two-year targeted (supplemental) intervention designed for students grades 6-12 who are two to five years below grade level in reading proficiency. This instructional framework consists of strategies surrounding the following four strands of a quality reading program: vocabulary, comprehension, fluency, and independent reading. Teachers will be trained in understanding the four key reading strands, scheduling and planning for classroom implementation, and analyzing data to make instructional decisions.

It is highly recommended, but not required, that at least two teachers, an administrator, and a curriculum director or literacy lead from the same school/district sign up together to provide collaborative support.
