Each term includes a three (3) week trial/grace period so that students and schools can make sure it is a good match. Teachers gain valuable professional development and experience to create or improve their own local digital lessons and courses.

# **LEADING, TEACHING, LEARNING SERVICES**

**Biliteracy Seal:** A new law passed last session to offer the biliteracy seal to districts to honor students who graduate from high school literate in 2 or more languages, one being English. The guidance is <a href="here">here</a>. We would love 100% participation from districts.

Computer Science is Elementary: The Computer Science is Elementary is a new opportunity through the Governor's Office, DE and Governor's STEM Advisory Council. The goal of the program is to transform six high-poverty elementary schools into showcases of outstanding computer science education, including career exploration with employer partners. Each school will serve as a statewide resource to other schools. The selected schools will receive a \$50,000 grant to help fund professional learning, curriculum development, site visits, district costs, and staffing. The application template, scoring rubric, and Frequently Asked Questions are all available online. The application window is January 15 through March 15. Districts will be notified during summer 2019 and awards must be used by June 30, 2021.

Core Advocates Professional Learning: ELA and mathematics educators are being encouraged to participate in the 2018-19 lowa Core Advocate monthly webinars that provide deeper understanding of <a href="the Shifts">the Shifts</a> necessary to implement lowa's Academic Standards in ELA/literacy and mathematics and where to find and best use standards-aligned resources, tools, and instructional practices. This year's webinars will integrate content from previous webinars with new learning to ensure we meet the needs of all participants. The webinars begin next week; access a complete schedule with times under the "Webinars" tab on the lowa Core Advocate <a href="website">website</a>. Fine Arts: Five free self-paced professional development modules on lowa's Fine Arts Standards were released on September 24th and are now available at AEA Learning Online. The modules, designed by our statewide Fine Arts Leadership Team, aim to ensure that all educators across our state have equitable access to an understanding of lowa's Fine Arts Standards, as well as supports and resources. Educators can choose to take modules individually or all together, as may befit their stage of implementation, needs, and contexts. A license renewal credit option is available for \$105; interested educators can enroll in all the modules as a credit bearing course with an added coursework requirement. The modules, available on AEA Learning Online, are: Module 1: Introducing Iowa's Fine Arts Standards, Module 2: Understanding Iowa's Fine Arts Standards, Module 3: Applying and Connecting Iowa's Fine Arts Standards, Module 4: Assessing Iowa's Fine Arts Standards, and Module 5: Resources for Implementing Iowa's Fine Arts Standards.

In addition, Iowa's Fine Arts Leadership Team recently met on October 5th in Des Moines to begin planning our first ever statewide Iowa Arts Education Summit, co-sponsored by the Iowa Department of Education, Iowa Arts Council, and Iowa Alliance for Arts Education. The Summit will be held on June 20th, 2019 at the FFA Enrichment Center in Ankeny.

**Mathematics:** Bill McCallum (author of standards, Illustrative, and IM/OUR) is returning to Iowa on November 8th, 2018 to deep dive the coherence of the math standards with the Statewide Mathematics Leadership Team from 9 am - 3 pm in Huxley, Iowa. This supports the statewide work to strengthen our standards implementation, Building Block #2. There are a few seats left. There is no charge for this day. We will continue to learn about the standards, progressions, and algebra pathways to increase college and career readiness. RSVP - if you would like to attend.

**Science:** Implementation plan reminders 1.) By the end of 2018-19 school districts are to be implementing the lowa Core Science Standards in grades K-5 and 9-12, plus one middle school grade (6-8) of the district's choosing. 2.) K-5 - Starting this year all curricular and instructional decisions should be made using the new standards. This does not mean every lesson must be completely 3D or perfectly aligned but should be moving in that direction. 3.) MS - at least one grade level must be using the new standards for all students in that grade and the district should have a plan for

implementing at the other levels. 4.) HS - All standards for all students. The district must have a plan that all students in 9th grade will have a curriculum aligned with the new standards. a.) The district is not obligated to change requirements for students currently in 10-12. b.) If the school does not have pathway(s) where students will have a curriculum that is aligned to all standards, they will need to make adjustments in order to be in compliance

#### **EARLY LITERACY SURVEY OF ALL IOWA ELEMENTARY SCHOOLS**

It has been six years since the passage of lowa's early literacy law, and elementary schools have made considerable changes in their curriculum and practices during that time. To better understand the literacy instruction occurring in classrooms today, the lowa Reading Research Center (IRRC) is conducting a survey. The survey includes approximately 50 items that ask respondents to identify elements of their core literacy program such as the materials, class sizes, and amount of time spent on reading and writing instruction. Additionally, the survey asks for information about literacy interventions and summer literacy programs.

On November 12, the IRRC will email a survey hyperlink to all elementary school principals. One administrator per building will complete the survey, either the principal or the principal's designee who is most informed about the school's literacy instruction. The survey is estimated to take 20 minutes to complete. **All surveys are due by November 26.** 

Anonymized and aggregated results will be shared statewide—the responses of individual schools will **not** be identified. School personnel can use the survey results to reflect on their literacy programming compared with the average responses across the state. The IRRC and Area Education Agencies can use the information to plan the supports and professional development that will align with school practices.

The IRRC appreciates the help of superintendents in publicizing this survey and encouraging principals to ensure the survey is completed for their school. Emails can get lost in busy administrators' inboxes, so your support and effort will be critical to obtaining enough information to truly understand the current literacy practices in lowa. # Food Service Management Company (FSMC) Fact Sheet

If your district is considering contracting with a FSMC for nutrition services it is important to remember that the agreement for Child Nutrition Programs (CNP) is between the State Agency (SA) and the School Food Authority (SFA). Therefore, all responsibility for CNP operations remains with the school district.

# What to know before you procure FSMC services:

- Before you start the process of procuring FSMC services you must contact the SA.
- The RFP process to procure FSMC services must begin <u>no later</u> than the last day of February in order to use the FSMC services the following school year.
- Procuring FSMC services is a complex and time consuming process.
- If an FSMC assists in any way with the RFP for FSMC services, then that FSMC cannot submit a proposal.
- The Food Service Director (FSD) is usually an employee of the FSMC. The district must have an employee of their own who acts as a second FSD and is referred to as the Program Director (PD). The PD must meet hiring standards and meet training requirements of at least twelve hours per year, including at least eight hours of food safety training every five years.
- You must use state prototype bid documents.
- You may choose between a Fixed Price or Cost Reimbursable Contract. Oversight and Monitoring of a Cost
   Reimbursable Contract is much more time consuming and requires more experience than a Fixed Price Contract.

### The SFA's responsibilities continue after a contract has been awarded:

- The SFA must ensure that the FSMC utilizes a minimum of 95% of the USDA Foods (commodities) entitlement. The SFA must also reconcile the value of USDA Foods received against credit for USDA Foods from the FSMC at least twice a year and submit documentation of the reconciliation to the SA.
- An Advisory Committee must be established and meet at least twice a year. The Committee must consist of FSMC, parents, students, and teachers who meet to assist in menu planning.
- The SFA must monitor the FSMC twice a year for compliance. The monitor forms must be submitted to the SA.
- All menu changes must be approved by the SFA in writing.
- The SFA must establish all meal and a la carte prices.
- The SFA must file claims, distribute benefit applications, maintain the Benefit Issuance List of free and reduced students, conduct verification, and maintain control of the non-profit account.
- The SFA must reconcile FSMC invoices before payment.
- The SFA must ensure all terms and conditions of the Contract are observed.
- All costs for a Cost Reimbursable Contract must be verified at least twice a year.
- SFAs with Cost Reimbursable Contracts must ensure that all rebates, credits, and discounts are credited to the non-profit account.
- The SFA must ensure that meal patterns are met, accurate and complete food production records are maintained,
   Offer vs Serve is correctly implemented, Smart Snack documentation is on file, and proper food safety practices are followed.
