EXEMPTIONS AND WAIVERS

lowa Code 256.11(8) allows districts to apply for an exemption from some requirements. Exemptions are to be granted only if the request made is an essential part of a planned innovative curriculum project. The project must meet the education needs and interests of the pupils and be broadly consistent with the intent of the educational program described in lowa Code. These exemption requests are available in CASA and are due January 1 of the prior year.

A common exemption request is for the requirement all high school students participate in physical education activities during each semester they are enrolled. Block scheduling can make it more difficult to schedule students into physical education each semester or trimester. An exemption request must be made yearly in order to schedule students for only one semester of physical education. Instructions for accessing the application are on the website.

The third and fourth units of a world language are not eligible for an exemption, but the requirement may be waived on an annual basis. The waiver application is not due until August 23rd of the school year for which the waiver is requested. This is to ensure the district has the class available for enrollment, including for any new students who might move into the district over the summer. WINTER STUDENT REPORTING IN IOWA (SRI)

For all public districts and non-public buildings who report via SRI

The Winter SRI production site opens on January 7th with a certification deadline of January 31st. For districts and non-public buildings housing grades 9-12, the Curriculum Accreditation Report found on the Home page in SRI should be reviewed. Items to review include (but are not limited to) local course title and SCED course title aligning, Carnegie unit on course is accurate, courses are sequenced appropriately so that Carnegie unit calculations are correct, and all courses eligible for accreditation are showing. STATEWIDE VOLUNTARY PRESCHOOL PROGRAM FOR FOUR-YEAR-OLD CHILDREN - NEW DISTRICTS

School districts not currently participating in the <u>Statewide Voluntary Preschool Program</u> (SWVPP) may apply to become part of the program. The application to begin a new preschool program in 2019-2020 is now available on the Department's <u>website</u>. This non-competitive application, which is due April 5, 2019, will require districts to fund the preschool program using other funding sources in 2019-2020. In the second year of SWVPP implementation, districts will receive state aid based on the number of eligible children served in year one. Additional details are included in the <u>December School Leader Update</u>.
