#### **IDEA Part B Desk Audit due**

IDEA Part B Desk Audit is due 11/1. This collection will be available 10/15 and can only be submitted by superintendent. If the district's IDEA Determination is "Meets Requirements," the only action is to acknowledge receiving the determination by submitting by the deadline. If the district's IDEA Determination is "Needs Assistance," contact information will need to be provided for district person with whom the Department should follow up.

Consolidated Application for Federal Title Program funding is due 10/15. The consolidated application must be submitted by the superintendent or their designee by this date. Designee information is collected on the consolidated application dashboard.

# Fall Student Reporting in Iowa & Certified Enrollment

Count day this year for Certified Enrollment is Tuesday, Oct. 1. Only students being served on that day are eligible for funding – students expected to move into your district and students that may come back any day are not eligible to be part of your count.

Per lowa Code (257.6), the certification deadline for Certified Enrollment (public and nonpublic) is **Oct. 15**. Be advised, there will be no SRI consultants available to assist districts on Saturday or Sunday of that weekend.

Districts are encouraged to wait until the November Board meeting to share any counts from Certified Enrollment with their school board or the public. Due to the new collection process, this is even more important this fall. Make sure that your contact information is up-to-date on the Fall SRI application. This is the source for all emails, announcements and notifications.

## **Biliteracy Seal**

The Seal of Biliteracy is an award to recognize students who have attained proficiency in two or more languages. Updated guidance is now available for districts who wish to participate in the Seal of Biliteracy. You can view the new guidance <a href="https://example.com/here">here</a>.

### Financial Literacy

The Department has released an <u>updated financial literacy guidance document</u>. Governor Reynolds signed SF139 into law during the 2019 legislative session that changes the implementation of lowa's new financial literacy requirement (SF2415) to the graduating class of 2020-2021.

#### **Social Studies**

Two years of professional development modules in social studies are now available for educators statewide. These modules are free and available anytime from AEA Learning Online.

#### **United States Senate Youth Program**

High school students interested in pursuing careers in public service are urged to apply for the United States Senate Youth Program. Established in 1962, annual program will be held in Washington, D.C., from March 7-14, 2020. Two student leaders from each state, the District of Columbia, and the Department of Defense Education Activity will gather for an intensive week-long study of government and those who lead it. In addition, each selected delegate receives a \$10,000 scholarship. The overall mission of the program is to help instill knowledge of the American political process and a lifelong commitment to public service. There are numerous deadlines in applying for the program, the first of which is Oct. 1, 2019.
